

**2016 RIVER RISE O'LENO COMPETITIVE TRAIL RIDE SEDRA**

**River Rise Preserve State Park offers primitive equestrian camping off of US 27. The area can accommodate up to 40 rigs, (IF NECESSARY, WE WILL LIMIT ENTRIES) including tents. The area contains a 20-stall horse barn on a first come, first serve basis, a restroom with showers and two established fire circles. There are no electric or water hookups in this camping area. Equestrians are required to maintain written proof of negative Coggin's test for Equine Infectious Anemia for all horses while at River Rise and on the trails. Well behaved, leashed pets are allowed in the camping area, but not on the trails.**

**SEDRA RIDE REQUIREMENTS:** Entries are open to all breeds of horses or mules 4 years of age and older as of ride date for the CTR 25. Entries must be accompanied by your total entry fees and signed release(s). Last day to cancel and receive a refund is December 12, 2016. Refunds will have a \$25.00 office fee deducted and will not be mailed until after the ride date. There is an AHA Regional 25 mile CTR championship as well see below for details.

**\*\*25 Milers and Introductory Riders: Check in on Saturday afternoon and ride 25 miles or Into Rides (do one IDR and then if fit to continue and you feel good, do another IDR with vet approval) on Sunday. MILEAGE ONLY HORSES FOR ANY DISTANCE MAY COME THE MORNING OF RIDE WITH ADVANCE APPROVAL OF MANAGEMENT but all others (except Introductory Riders) must arrive the day before the ride starts and camp out with your horse!** JUNIOR RIDERS: Riders under the age of 19 will compete in the Junior Division. It is the responsibility of the parent or guardian to ensure that Juniors 16 and under must be accompanied on the ride at all times by a parent or designated sponsor. Sponsor forms must be signed by sponsor before the ride begins and ride with their junior(s).

**RIDE RULES:** This is a SEDRA sanctioned ride. All SEDRA rules will apply including but not limited to the following: **ALL RIDERS MUST WEAR A HELMET WHEN MOUNTED.** EXTERNAL AIDS: Only water and grooming aids may be used; no hoof dressings, ointments, salves or other medications may be used except as authorized the judges. No boots or other protective devices may be used on the horse's legs unless you are riding mileage only. No restriction on shoeing. Easyboots may be used.

**DRUGS AND MEDICATIONS:** No horse competing shall be given an illegal drug or medication for the purpose of altering the horse's performance. Illegal drugs are defined as, but not limited to, any stimulant, depressant, tranquilizer, local anesthetic, anti-inflammatory or analgesic (including Bute and Banamine) or any medication that alters the distribution of body fluids. The finding of a drug or its by-product in the blood, urine or saliva of a horse will be used as evidence that such was illegally administered. There will be random drug testing using SEDRA rules. **SEDRA RULES CAN BE FOUND ON THEIR WEB SITE: [www.distanceriding.org](http://www.distanceriding.org)**

**WATER:** No hoses are allowed to be used on horses after you have vetted in. Mandatory holds will be at base camp and on trail. Ride management will transport water buckets to the away 20 minute hold. Riders may put out buckets, hay etc. in the designated area for the mandatory hold and CRI at the end of the ride.

**WARNING RIBBONS:** A red ribbon must be worn in the tail of any known (or suspected) kicker. All stallions must wear a yellow ribbon. Ribbons should be securely fastened into the tail. It is the rider's responsibility to furnish their own ribbons. Rookies wear green please!

**TRAIL:** These are multi-user trails for equestrians, hikers, and 'fat tire' cyclists. The trails primarily consist of single track trails with one major road crossing. Each rider is the responsible for stopping and yielding to traffic as traffic has the right of way.

**AWARDS:** Completion and six places in each weight division, plus Grand and Reserve Champions of the ride. Juniors have their own division and are not eligible for Grand or Reserve. Proof of a horse's registration is required to be eligible for breed awards.

**AHA DIVISIONS:** Any registered Arabian or Half/Anglo Arabian that is 4 years and older may enter the AHA division – as long as you have done 50 miles in the last two years – one must be a 25 mile CTR by an approved AHA CTR organizations (e.g. SEDRA) and a LD may be used as the other 25 miles or two CTR rides. The rider and owner must be current AHA competition members. You may JOIN at the ride through Arabian Distance Riders Association for \$75 for seniors if you link to our Club (rolling year so Dec 1 – Nov 30, 2017) or \$45 for juniors who have not reached their 19<sup>th</sup> birthday. So call AHA at 303.696.4500 to join in advance, or go online at [www.arabianhorses.org](http://www.arabianhorses.org) or join at the ride. AHA Region 12 provides for a champion, reserve champion and Top Five (3) in the Arabian and Half-Arabian Divisions plus a high point junior award. For achievement award points, the AHA 50% rule applies. Top Five Awards will be given regardless of how many horses compete in each division at the start of the ride. Points in the Horse Achievement Award, Amateur Achievement Award, High Point Horse Achievement Award, High Point Amateur Achievement Award and Distance Award Programs will be given to those horses enrolled in these programs equal to 50% of the division rounded up not to exceed five of those competing in the division at the beginning of the ride.

**AHA QUALIFICATIONS:** Qualifications. All horses ridden in a Regional Championship Competitive Trail Ride must have qualified in a Competitive Trail or Endurance Ride held within the two preceding calendar years and that period of the current year prior to the closing of entries for the ride at which the Regional Championship Ride is held (so 2014, 2015 and 2016) and will meet one of the following criteria:

- a. Complete 50 miles of an AHA Recognized/Approved competition of no less than 25 miles per ride. At least 25 miles must be Competitive Trail miles. See CT 103.1.a for the Approved List.
- b. Placing Top Five in a Regional Championship Competitive Trail Ride.
- c. Placing Top Ten in a National Championship Competitive Trail Ride.
- d. Previous recognized National Champion Competitive Trail Horses are qualified for life. Previous Reserve National Champion Competitive Trail Horses are qualified for four years, plus the portion of the current year prior to closing of entries.

**CHECK IN AND VET IN:** Registration will open at 2:00 PM on Saturday for 25 Milers and Intro Riders. Vet in estimated to begin at 3:00 PM, subject to change. The judges will examine your horse in hand and at the trot. Any faults, blemishes or unsoundness must be noted on your scoresheets and evaluated for starting at that time. **Please plan to attend Ride Meeting to be aware of any updates.**

**STARTING ORDER:** Your number MAY be your starting order. Numbers may be assigned in the order in which entries are received although we may set up groups who wish to ride together. If you want, you may request a LATER starting position on your entry form, but not an earlier one. The ride starts at 7:30 am ESTIMATED (or at the discretion of ride management). Juniors may leave with their sponsors. Riders must display their numbers at their campsite.

**TIME ALLOWED:** A range of 3:55 and 4:40 is the normal time allowed to complete SEDRA 25 miles without penalty; which includes one 20 minute P&R/safety mandatory hold. Time includes all vet and water stops. Any rider more than 30 minutes late (or early) will be disqualified. All checks will be in camp. **NO SMOKING ON THE TRAILS!** Introductory Riders will have 3 hours to complete the loop. AHA time is an optimal time to be announced at the ride meeting and AHA competitors must come in 15 minutes before or after this optimal time or be disqualified. AHA Optimal time is 4:15 so +/- 15 minutes is acceptable. Outside of this window, you will be disqualified from the AHA ride. **CAMPING:** Primitive Camping ONLY -No electric available. Bring your own PEOPLE water – there is horse water available. Portable Paddocks or High-Ties may be utilized. There is ONE hose that is near the barn. Please do not tie directly to trees or fences. GENERATORS – must be off between 10 pm-5:30 am. All rules of the forest must be observed. Anyone breaking these rules may be asked to leave. No firearms or narcotics are permitted. Please leave the grounds as clean as you found them – remove or spread hay, and really spread the manure! **PLEASE. YOU MUST CLEAN UP YOUR CAMPSITE OR WE MAY CHARGE YOU \$25 SO THAT WE ARE WELCOME BACK!** Remember, each horse owner, trainer and/or rider is responsible for safe camping and restraint of their horses.

**ALL DOGS MUST BE KEPT ON A LEASH OR IN A KENNEL. NO DOGS ARE ALLOWED at meals or meetings!**

**FOOD: POTLUCK DINNER SATURDAY NIGHT** - Chicekn will be provided for Riders, Officials, and Volunteers. You guys are amazing about the food you bring! Others may purchase a meal ticket for \$8.00. Trail snacks will be provided on Sunday. Coffee and rolls/muffins are provided Sunday morning.

## **AHA ENTRY AGREEMENT – Regional and Local Ride**

I have read the rules concerning competitions as printed in the Arabian Horse Association<sup>✉</sup> (AHA<sup>✉</sup>) Handbook and Directory and agree to be bound by and subject to those Rules.

### **AHA ASSUMPTION OF RISK, RELEASE AND INDEMNIFICATION**

#### **This document waives very important legal rights. Read it carefully before signing.**

In consideration for AHA permitting me to participate in this Competition, and by signing the entry blank, I agree as follows:

**I AGREE** that I choose to participate voluntarily in this Competition, as a rider, driver, handler, lessee, owner, agent, coach, trainer, junior exhibitor, or as a parent or guardian of a junior exhibitor. **I AM FULLY AWARE AND ACKNOWLEDGE THAT HORSE SPORTS AND PARTICIPATION IN THIS COMPETITION INVOLVE SERIOUS RISK OF HARM INCLUDING, BUT NOT LIMITED TO, RISKS OF ACCIDENT, SERIOUS BODILY INJURY, INCLUDING DEATH, BROKEN BONES, HEAD INJURIES, TRAUMA, PAIN, AND SUFFERING, AND PROPERTY DAMAGE. I ASSUME ALL RISKS OF HARM TO ME, MY HORSE OR MY PROPERTY.**

**I AGREE** for myself, my heirs, executors, administrators, successors and assigns to **release** AHA, the Competition, the facilities leased by the Competition and the owner(s) of the facilities, and all of their respective officers, officials, directors, employees, agents, personnel, volunteers, affiliated organizations and insurers (collectively, the "Released Parties") from any and **all claims for damage, loss, or injury to myself, other persons, horses or other property** belonging to me to the fullest extent permitted by law that arises out of or relates in any way to the Competition and my participation in the Competition **INCLUDING, BUT NOT LIMITED TO, DAMAGES, LOSS, OR INJURY RESULTING FROM ANY ACTS, FAILURE TO ACT, NEGLIGENCE OR NEGLECT OF OTHER ENTRANTS, THE RELEASED PARTIES, THEIR CONTRACTORS OR INVITEES**, as well as for theft, vandalism, fire, other casualty damage, or damage arising out of any defects in the premises.

**I AGREE to indemnify and hold harmless** (that is pay all losses, damages, attorney's fees and costs of) the Released Parties from and against any and all claims, demands, penalties, actions, losses, costs, damages, injuries, liabilities and obligations (including attorney's fees) of whatsoever kind and nature, which may be asserted against or incurred by any of them as a result of (1) my participation in the Competition or (2) any act, failure to act, or neglect (a) by me, my agents, employees, riders, handlers, trainers, coaches, drivers, contractors or invitees, or (b) by any animal owned or exhibited by me or in my custody or control.

**I AGREE and represent** that I am qualified and eligible to enter and/or participate in the Competition, and every horse I am entering is qualified and eligible as entered.

**I AGREE to accept AS FINAL** any decision of AHA, the Ride Management Committee or Ride Officials concerning my qualification or the qualification of my horse to enter the Competition or any results of the Competition, except to the extent that the Rules of AHA or the Competition permit a protest or hearing of such decisions. Should a hearing be requested, **I agree to accept AS FINAL** the decision of the particular hearing body. **I agree to release, hold harmless and not to sue** AHA, the Competition Sponsor, their officers, directors, employees, volunteers or members concerning any decision of AHA, the Competition, its Ride Management Committee, Ride Officials or any hearing body that relates to my qualifications or my horse(s)' qualifications to enter the Competition or any results of the Competition.

**I AGREE** that AHA has the sole right to control, sell, supervise or give away (or assign to others the right to do so) the exclusive rights to broadcast, televise, reproduce, transmit and disseminate all or part of this event, and I agree that AHA may use or assign, in any way AHA sees fit, photographs, films, videos, audios, cablecasts, or other likenesses of me and my horse taken during the course of the Competition for the promotion, coverage or benefit of the Competition or AHA. Those likenesses shall not be used to advertise a product and they may not be used in such a way which implies endorsement of any company, product, product category or service. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation.

By signing below as a parent or guardian of a junior exhibitor, I consent to the child's participation and agree to all of the above provisions, and further agree to assume all of the obligations of this AHA Assumption of Risk, Release and Indemnification personally and on behalf of the child.

**This AHA Assumption of Risk, Release and Indemnification** is governed by the Laws of the State of Colorado and is intended to be interpreted as broadly as possible. I agree that exclusive jurisdiction and venue (place) for any legal action against AHA, its officers, directors, employees, volunteers or agents shall be in the local district courts or the federal court of the State of Colorado. If any part of this agreement is determined to be unenforceable, all other parts shall remain effect.
