**TBA CLASSES**: All A/HA/AA classes are available as TBA classes except working cow horse/cutting/team penning, any cow classes.

**LEAD-LINE:** 6 & UNDER - Open to Arabians and Half-Arabians, rider to be at least two years and have not reached their 7<sup>th</sup> birthday by December 1 of previous year. Leaders must be at least 14 years of age. Only one rider per horse, saddle must fit the rider and the rider's legs must be engaged in the stirrups. Stallions are prohibited. Safety is paramount, and helmets with chin straps should be used.

**WALK-TROT:** 10 & UNDER PLEASURE/EQUITATION – Open to Arabians and Half-Arabians, rider to be 10 & under. Rider not to have cantered in a show. Rider may not ride in any other class at this show except Walk Trot classes

**WALK or WALK-TROT: ADULT – Pleasure and Equitation –** Open to Arabians and Half-Arabians, rider to be over 18. Rider not to have cantered in a show. Rider may not ride in any other class at this show except Walk or Walk-Trot classes.

**LIBERTY:** Provide your own two minutes of music, no more than two handlers; you must be able to catch your horse within one minute from the end of music or be disqualified;

**IN ALL MEDAL CLASSES-**To award a medal, three competitors with proper appointments must be entered, shown, and judged.

**MULTI-BREED DRESSAGE CLASSES:** These classes are offered but do not receive any USDF or USEF credit. The dressage rules in multi-breed classes revert to the breed restricted (in this case Arabian Dressage) rules.

**ACADEMY CLASSES**: Academy classes are classes limited to horses used regularly in a lesson program. There are no attire or tack requirements, although normal welfare of the horse tack regulations apply. Exhibitors may not cross-into any other classes at this show.

### **Membership Statement:**

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, or agent at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) assistant handlers in Dressage Sport Horse Breeding classes

### **Safe Sport Reminder:**

Reminder: All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. #### **Motorized Vehicle Statement:**

Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties.
